Tailored Day Services (TDS) is a part-time day program for community integration via volunteerism, work readiness and education. This program is 6 years old. We volunteer at a number of non-profits and government agencies in Solano County. Work Crews support local businesses and a number of people take face to face or online community college classes. Transitional Service (TS) is now 44 years old. TS Staff have provided tremendous support to adults wishing to live more independently. Areas of assistance includes health, housing, and money management. Value added programs include theater, literacy, and beaddazlers and ART@ARC.












